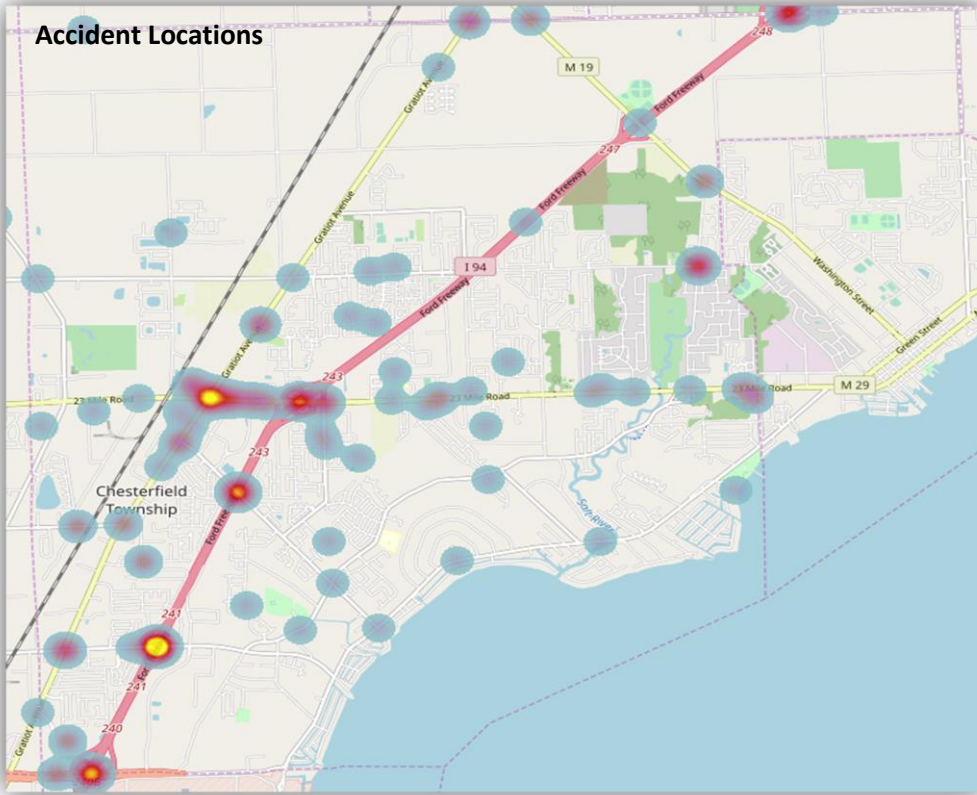




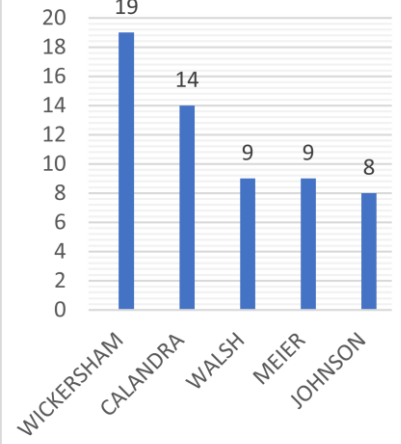

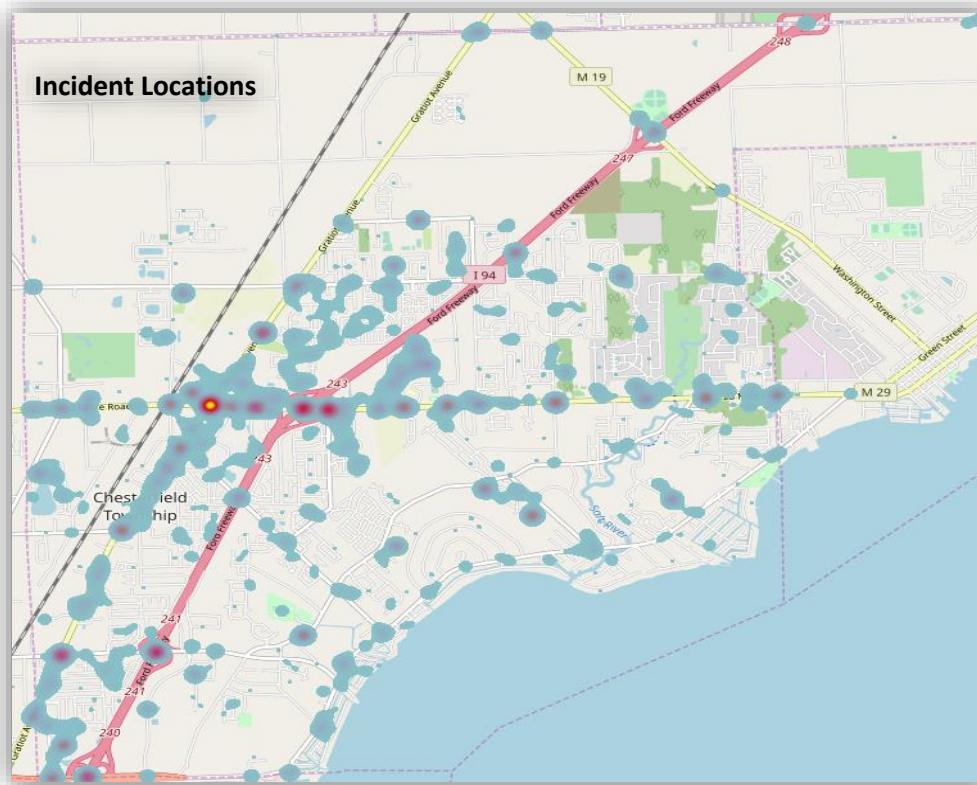
Accident Locations



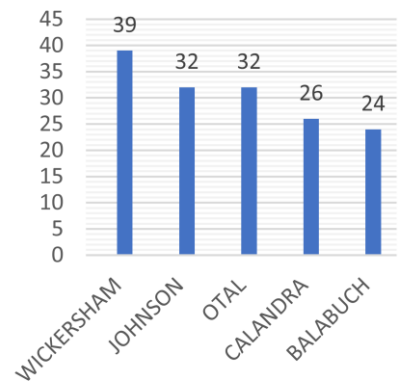

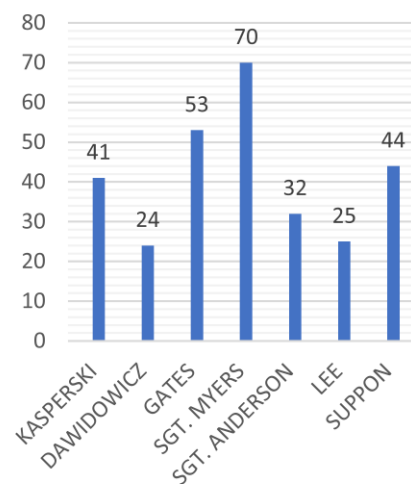
Incident Locations

2019-1650 Det. assisted with fatal accident. Interview with suspect resulted in confession for OWI. Still under investigation.

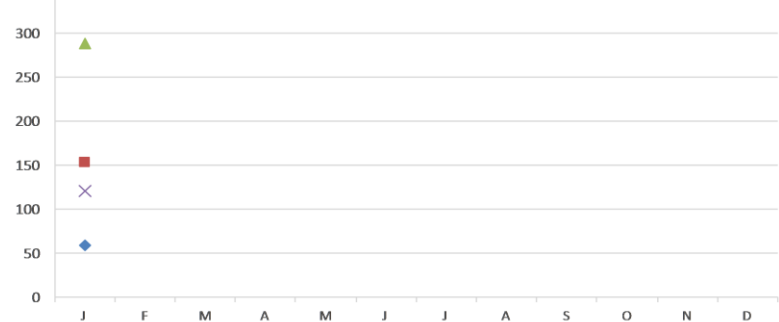
2019-988 Det. investigated infant death. Still under investigation.

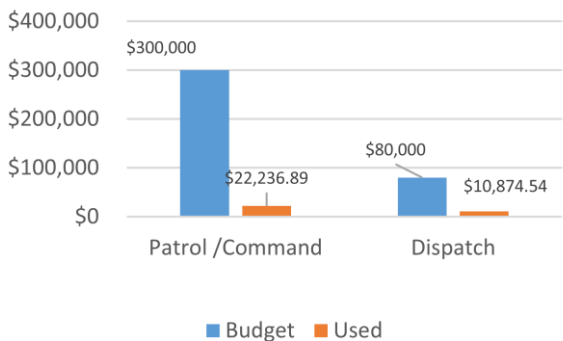

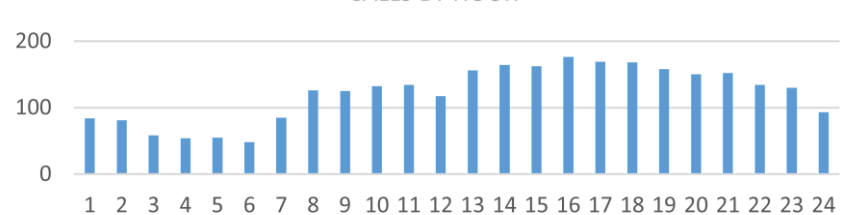
