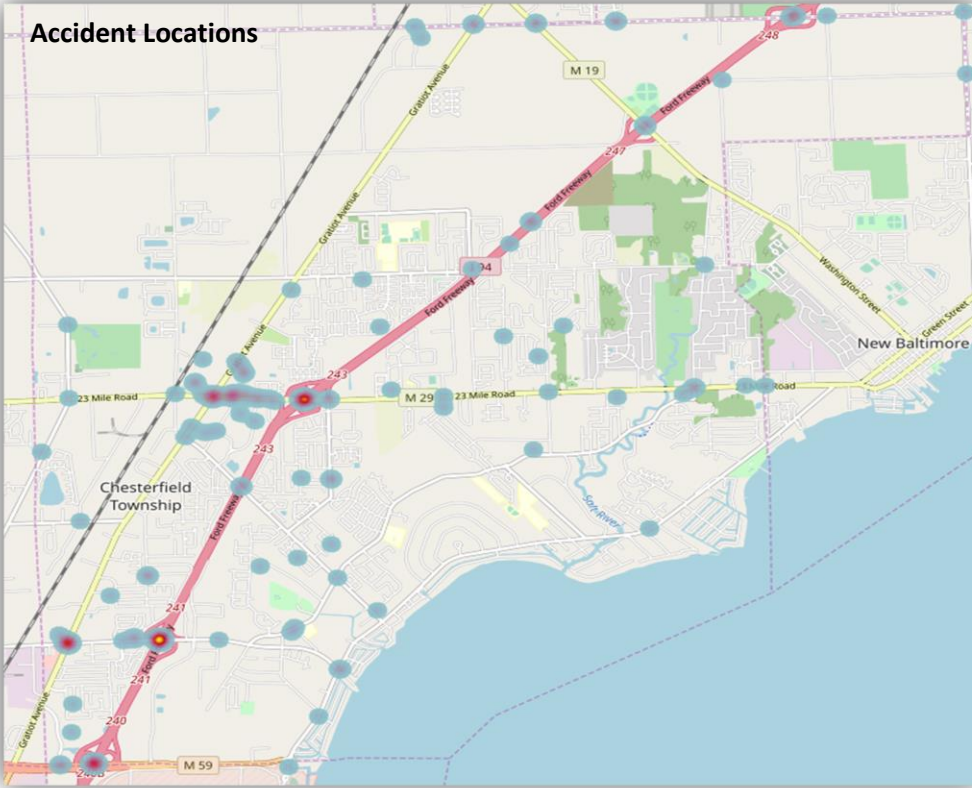




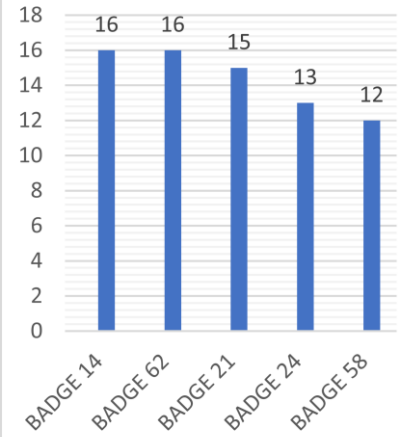

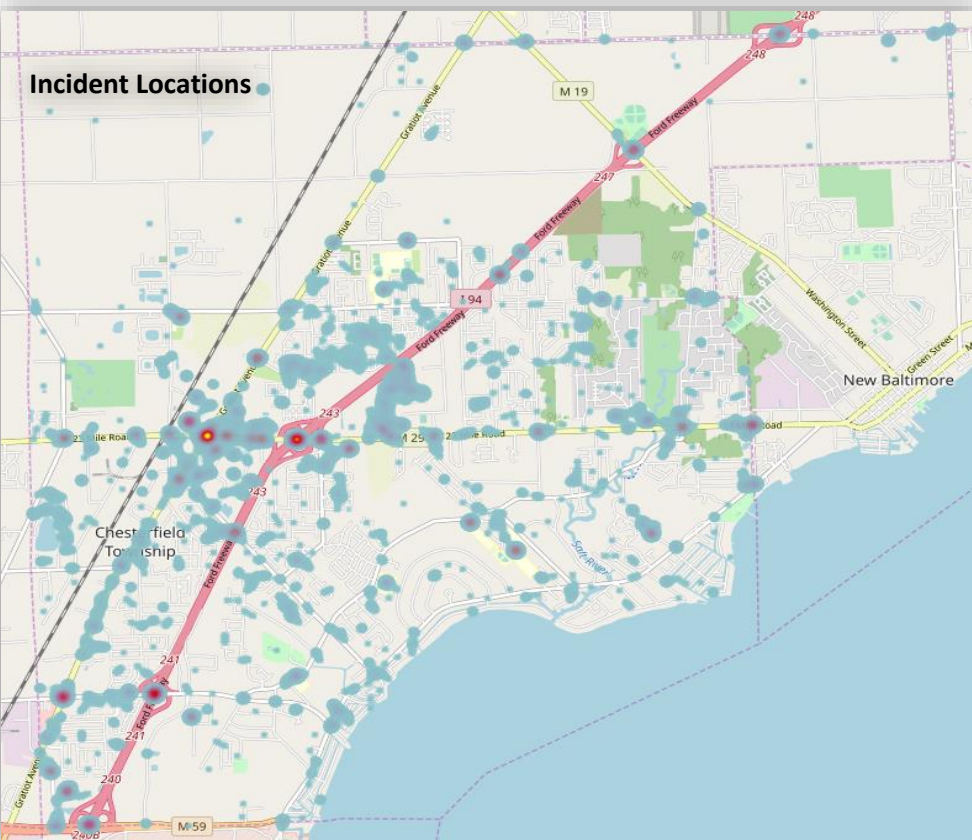
### Accident Locations



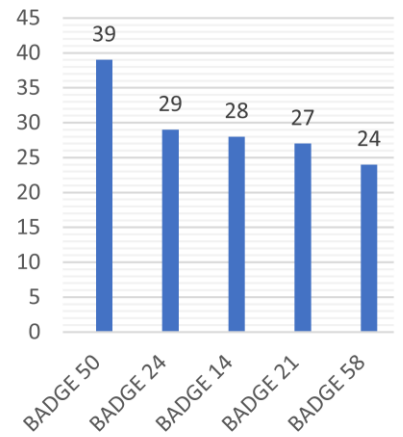

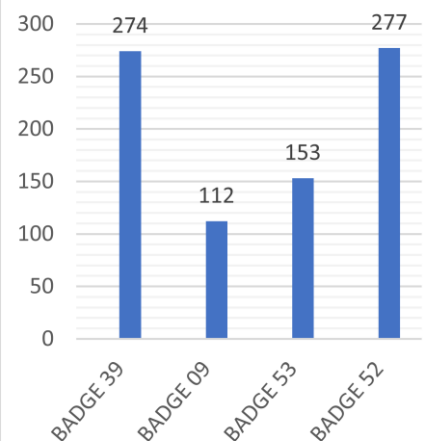
### Incident Locations

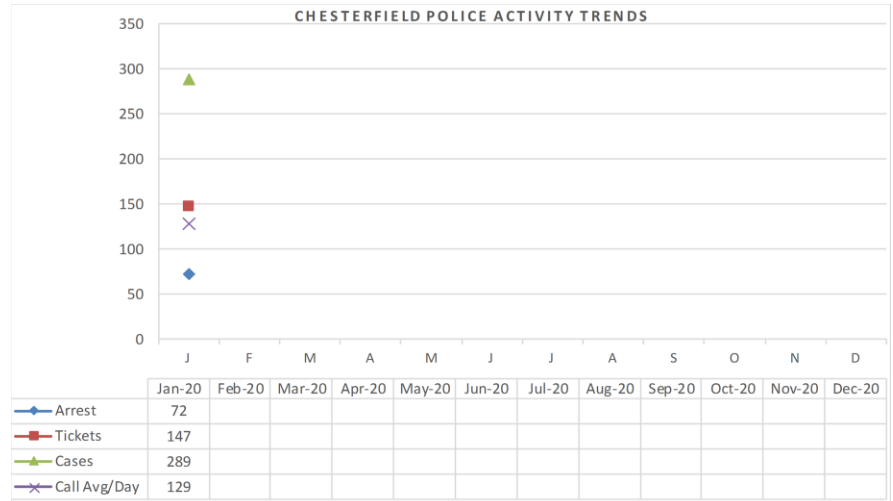

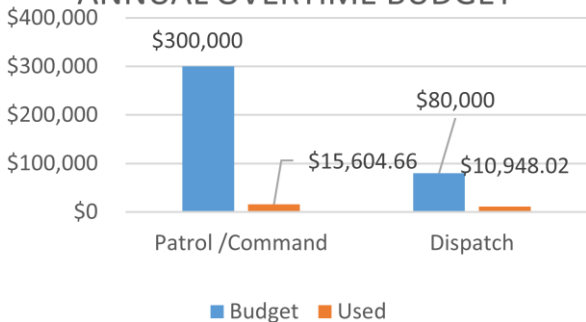
