PLEASE TAKE NOTICE that any qualified elector of Chesterfield Township, who is not already registered, may register to vote at the office of the Township Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at <http://www.expresssos.com> and mailed to the Township Clerk. Those who have a valid Michigan driver's license or state ID may register to vote or update their voter registration online at www.mvic.sos.state.mi.us/register voter

The last day to register in any manner other than in-person with the local clerk is **July 18, 2022**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the Chesterfield Township Clerk's Office, located at 47275 Sugarbush Rd., Chesterfield Twp., MI 48047 at the following times:

- Regular business hours: Monday - Friday from 8:00 a.m. to 4:30 p.m.
- Saturday July 30th from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday August 2nd from 7:00 a.m. to 8:00 p.m.
