PLEASE TAKE NOTICE that a petition has been filed with the Township Board of the Charter Township of Chesterfield signed by the record owners of the above described lands constituting more than fifty (50%) percent of the total road frontage to be benefitted by the road maintenance improvements described in and proposed by said petition, and that the Township Board has tentatively declared its intention to make said improvements, particularly described as follows:

THE ROAD MAINTENANCE IMPROVEMENTS ARE DESCRIBED AS:

Road maintenance for a five (5) year period consisting of annual quarterly gradings of Hickock Road and two applications of 45 tons of 21AA limestone gravel at an estimated cost of \$3,850 per year.



Specifications and estimates have been prepared and are on file with the Township Clerk for public examination.

TAKE FURTHER NOTICE that the Township Board will meet on February 28, 2023 at 7:00 o'clock P.M. at the Township offices, 47275 Sugarbush Road, Chesterfield Township, Michigan for the purpose of hearing any objections to the petition, the installation of said proposed improvements and the creation of a special assessment district therefor.
